Here are the movements and moments your sponsorship supported in the tumult of 2020:

• We pivoted to community organize over ZOOM — among our 9 circles of faith-rooted community leaders — 4 regions of housing advocates, 5 immigrant—accompaniment cohorts, plus 2 circles of youth involved in justice systems. They are protecting housing budgets and immigration policy across the county and the state. They are strengthening local community organizing. This is the long-term work that needs to be done even during this crisis.

- The Immigrant Accompaniment team pivoted to raise and share direct aid to 100 households who were not eligible for other support with \$22K of rental assistance and delivery of 1022 food boxes, plus accompanying community members to sensitive meetings.
- The Youth Chaplaincy Coalition supported youth online and by telephone even when mentors and chaplains couldn't visit facilities. They showed up in creative ways, continuously leading our juvenile justice systems into better ways of connecting.
- During 2020 our organizers also set vision for 2 new initiatives: addressing our need to grow in racial equity and support congregations grappling with their futures...and pasts.
 - Organizing Fellows: year-long paid positions invest in the leadership of folks from the neighborhoods where we organize
 - o Faith Land Cohorts: congregations who are considering how to use "their" land learn & share an organizing process inviting awareness of privilege, building clarity within the congregation, & generating responsiveness to neighbor needs. This effort was piloted in 2020 because of support from the 2nd Century Fund launched during our 100th Anniversary Celebration -- the past investing in the future.
